I. <u>EXECUTIVE DIRECTOR COMMENTS.</u>

Ray Helmcamp explained that in September we will have two (2) ex-officio non-voting members join the Board per the new law SB632. They will be appointed from the local sheriff's department and have a 2 year appointment. This schedule will allow for a rotation of counties to be represented on the Board. Ray Helmcamp further informed the Board

that on September 17, 4-6PM we will have an Open House celebration with a ribbon cutting at 5PM with Belton Chamber of Commerce to celebrate the new IDD Center. Mental Health leadership is reviewing a lease agreement for Advent Health for a Copperas Cove location to be established by October 1, 2019. This clinic will tentatively support the full range of services. Rocky Frame will identify the staff and logistics and will address the consumer needs in that area. Sue Faulkner sent an email to Ray Helmcamp to discuss a need for a presentation on the awareness to mass shooting and violence, highlighting myth vs. fact. This could be presented to the community as well. Ray Helmcamp shared with the Board that Rita Kelley and Dr. Avots-Avotins are new Board members from Bell County.
